V. New Business

A. Hollywood Bowl – (D. Elliott) Thanks again to Matt Stern for taking on the role of Hollywood Bowl Coordinator! Bowl prices have gone up again. D. Elliott asked M. Walker to purchase more weekday tickets than usual for the *Amadeus* movie night and *Rhapsody in Blue* concert because she anticipated increased interest. She thought the weekday ticket price was \$1, but the new price turned out to be \$8. Saturday tickets have increased from \$17 to \$25.

Amadeus Live in Concert – 50 weekday tickets bought / \$8 per ticket Rhapsody in Blue – 40 weekday tickets bought / \$8 per ticket Rachmaninoff - 40 weekday tickets bought / \$8 per ticket

Because so few people showed up for the picnic before the Bowl Saturday concerts last year, it has been suggested that for this year we opt out of reserving a picnic spot for \$60, and instead have people meet at our reserved seats and picnic there.

Elliott was concerned about being able to afford price increases, so she consulted with B. Smith about last year's Bowl expenditures. \$2069 was spent last year, and we recouped \$1097.05 from member's contributions, amounting to a net expense of \$971.95

With these numbers, not accounting for PayPal fees for those who chose to pay online, Looking at an initial outlay expense of \$2460, and recouping around \$1200-\$1260, assuming members pay half the ticket price. This would mean an estimated net expense of

around \$1300, including PayPal fees. A few hundred dollars more seems manageable and affordable.

(Walker) – to be clear, we're asking members to cover \$4 of the \$8 ticket price.

It was decided at the Sept. 2019 board meeting to reduce the Saturday ticket purchases from 70 down to 60. It wasn't a formal motion, simply an understanding amongst those handling ticket purchases. Tickets are refundable with 6 weeks advance notice, so we might be able to save some money if we don't reserve all 60 seats.

(Elliott) A new motion is not necessary. The aforementioned numbers were officially approved in the June 2019 board meeting budget discussion. Just wanted to make the board aware of the \$300-\$400 increase in Hollywood Bowl ticket outlays.

For \$25 Saturday tickets, instead of having members pay exactly half (\$12.50), we are going to round it up to \$13. Any member can reserve up to 4 tickets for any event.

(B.Lee) suggested selling tickets on the GLAAM website by installing a PayPal button. Report can be sent to Matt Stern.

Matt Stern is working on an advert for LA Mentary and website.
